- 3.01 Election term limits
 - Mr. Barnes; tomorrow in our newsletter, we will have information about question 5A on the ballot.
 - It will give just the facts that the board members up for re-election, if they choose to run will have to go through the normal steps. They do not get to just stay on the board.
- 3.02 BOCES Cooperative Educational Service Contract
 - Mr. Barnes, just the normal BOCES contract. We will see an IT contract and one for any students we have going to BOCES.
 - You can see we get credit for all the grants that BOCES receives and it takes the invoice down to a manageable amount.
- 3.03 Classified Education reimbursement
 - We have classified personnel working on their teacher certificate and wanted to know if they could be reimbursed for classes, I said yes. I wanted to bring this to the board to make sure we are on the same page. We have never really talked about it.

- 3.04 Read Act Grant
 - Mr. Barnes. CDE has thrown a wrench in the read act for next year. My kindergarten through third teachers must complete 45 hours of training or pass a test for \$168.00 by the beginning of next school year or we will not receive Read Act Dollars. The Read Act is about \$10,000 a year. To be frank with you, it will be a tough sell to get these teachers to complete this in the next 6 to 7 months. We are not pushing this for our staff.
 - Mrs. Hartley, They rolled this requirement with 45 hours of training. They
 also have other items you can use to cover this requirement like the praxis
 test, if we have other training that teachers take we could apply and do the
 paperwork to see if that training will work, your work study that you used
 for your degree. CDE did a webinar and said there were a few exceptions
