- 3.01 2023-2024 Budget
 - Ms. Klunder, they are the first few pages in your packet, it is all broken out so you can see Salaries, Benefits and expenses. Mr. Davis, on the first page where it says salaries, is that for a specific person? Ms. Klunder, the specials teachers, Art, Music and PE a percentage of their salary goes to Elementary, Secondary and then HS to PE and CTE. Mr. Davis, it went down this year? Ms. Klunder, yes. We lost a teacher and the new teacher coming in makes less pay.
 - Mr. Barnes, this is our preliminary budget. We will have our final budget in December. The State is finally done with the long bill. Our final PPR is \$14,029.00 per FTE. Remember we budgeted on \$13,500.00. We talked about raises and those are in this budget, \$1.00 an hour and \$3,000.00 for teachers. The new kindergarten teacher and Para, the new air conditioner/heater for the gym. The legislator also approved the rural school money, we will do the Christmas cost of living with that and the rest on the Air Conditioner. There are not any surprises in this budget.

3.02 Summer Hiring

• This is for summer hiring as we do not have a board meeting in July. We bring the new hires to the August board meeting. This gives me the authority to offer a contract to someone without the board approval. Mr. Carneal, who is on the interview panel? Mr. Barnes, it depends on who is hiring. For the two para positions it will be Mrs. Hartley and people in her department. The Kitchen does their own interviews, we may have Glenda in with them for HR. Mrs. Hartley, Sharon Webb and Amy Berwick and myself will be conditioning the interviews. Mr. Davis, will we be hiring another Elementary Secretary?
