Mr. Davis, we need to update the information on Policy BE, fill in the blanks. Mr. Carneal, on policy BDF we need to cross out the cross reference for KCB as we are repealing that policy. Mr. Davis, why are we repealing that policy? Mr. Carneal, it is not needed. Mr. Davis, then just line out that cross reference. When we update the policy, it wont show up. Mr. Bringhurst, Dan I have a question. In the top note on BDF it says, "while Colorado school districts are not required by law to adopt a policy on this subject". So, we adopt a policy that is not a law. Ms. Klunder, we are just updating as it was adopted in 2007. Mr. Bringhurst, so we are going to go through and change the language somehow? Mr. Barnes, some of the content in there is required by the State. Mr. Carneal, it is something we already have since 2007 and we are just updating it. Mr. Bringhurst so maybe we should just repeal it.

Mr. Davis, Mrs. Hartley, If you look at the bottom of the policy BDF it says advisory committees shall be open to the public and the meeting notices shall be posted. That answers our question. Mr. Davis, we should move back BE (inaudible) to much paper shuffling to hear which policy to hold back. Mr. Bringhurst, it says if required. Mrs. Hartley, we are required by State law to have a DAC. Which is your district accountability committee.

Mr. Bringhurst, BDF Advisory committees does it correlate with anything in the repeal board policy KCB? KCB, we repeal a policy that says community involvement and we have to have community involvement for advisory committees. We are repealing one and adding another one, are they redundant? Mrs. Hartley, (inaudible). Mr. Carneal, did you hear them? He was asking about KCB and BDF, so repealing one and keeping the other. BDE updates the language. Mr. Bringhurst, I guess one of my issues with this example is, we have repealed through the vote community involvement in decision making. We are saying don't come here to help us make decisions. But then we are asking them to make an advisory committee. Is that Mr. Carneal, no

page 42 is the KCB Policy. Mr. Bringhurst, yes, I read it, I read through it quickly. That is what got my no vote. The community needs to be here in my opinion. We have repealed it. Mrs. Hartley, I think that the BDF advisory committees replaces that. Mr. Bringhurst, with different wording. I agree it does, that is my content. Mrs. Hartley, do you want to keep them both? Mr. Bringhurst, we work for the public and not an advisory committee. Mrs. Darby, in BDF it does say, we encourage the participation of the public. It does say it encourages the participation of citizens to help in the decision making of the board. Mr. Bringhurst, what page is the second one? But see the original one we have from 1985 has no State statue attached. So, it is autonomous, something that our district wanted back then. So, we are going to can that and use something that the State says? Mr. Carneal, Cross reference on the KCB sends you right back to the other ones, why do we need it multiple times? Mr. Bringhurst, This one says community groups and the other says all citizens. That is a big difference for me! I would rather have the old policy to be honest, than the new policy. One citizen, that is who we work for. My concern is in the last several years, you get community members locked out of board meetings. Mr. Davis, you can't lock the public out of the board meetings it is illegal. Mr. Bringhurst, you can't force them to make a committee either. Mr. Davis, The DAC and the Bullying committee from policy JICDE that is what they are talking about. Those are the committees they are talking about. Mr. Bringhurst, I am just bringing it up, I have already laid my vote.
