 - Prep Academy
 - Prep Academy Principal asked us to look at it.
 - It is not making our school any money, but we also are not losing money
 - \$16,000 in fees just for PPC just for the Prep Academy kids
 - We have to look at the Reduction and B & M Revenue from these kids
 - They do have alternatives but the Principal wants to be able to tell the students to make other plans if we close it.
 - If we do keep it, we may consider keeping the Ascent program kids only, but this will depend on the state decisions and what we can do
 - If we do decide to keep the program we will only keep those already on with us, we will not bring any new students in
 - Ascent if we don't use our slots then no one gets them
 - We can look at different options with Corinna
 - There is not really an advantage to us having it here at
 - Cost of Living
 - List of numbered staff members and their total cost of living handed out to board members
 - This money is already in our budget, it is under the rural school grant
 - We budgeted more than the bonuses actual are
 - It was asked if this is a common practice across the state, reply most of the schools in this area are doing this, but Dwight doesn't know about across the state
