Mrs. Darby said, “Other than I just feel we did the best with what we had.”

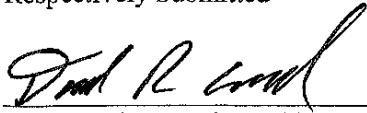

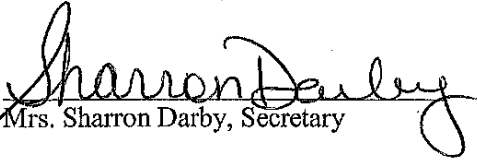
